On August 21, 2023, NYSED issued a report and Compliance Assurance Plan that identified the following areas of noncompliance: the program's lack of access to student IEPs, including changes to the IEPs; absence of 1:1 aides in the residence, as required per student IEPs; lack of parent counseling and training, as required per student IEPs; lack of regular progress monitoring of the frequency, duration, and intensity of the behavioral interventions at scheduled intervals, as specified in students' behavioral intervention plans; and staff's inability to identify reportable allegations of abuse and neglect per Part 200.15. To date, the program continues to work on rectifying identified areas of noncompliance specific to required parent counseling and training, and regular progress monitoring of the frequency, duration, and intensity of the behavioral interventions at scheduled intervals, as specified in students' behavioral intervention plans. Additionally in the Fall of 2023, NYSED conducted a Focused Review in the area of Delivery of Special Education Programs and Services. On December 22, 2023, NYSED issued a report and Compliance Assurance Plan that concludes the program continues to be noncompliant in the areas of parent counseling and training, and regular progress monitoring of the frequency, duration, and intensity of the behavioral interventions at scheduled intervals, as specified in students' behavioral intervention plans, as well as the provision of related services mandated by student IEPs. The program's corrections are due by March 22, 2024.	NYSED issued a Compliance Assurance Plan on August 21, 2023 as a result of the Monitoring Review conducted in the Spring of 2023. NYSED issued a Compliance Assurance Plan on December 22, 2023 for the scheduled Focused Area Review.
